WE HAD ALMOST 2,000 REGISTRATIONS FOR OUR WIT FORUMS AND SOCIALS AND OVER 750 ATTENDEES AT WIT CONNECT. WIT ALSO EXPANDED OUR EDUCATIONAL OUTREACH, REACHING MORE YOUNG WOMEN AND INSPIRING THEM TO PURSUE STEAM EDUCATION AND CAREERS.
